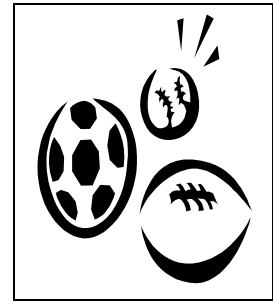

Parent Policies

- Drop-in recreation programs for school-age children are exempt from licensing requirements because, they do not provide child care. A drop-in recreational program is in a physical location that children can enter and depart at will. Children are not required to formally sign in/out. But program staff may request children to sign in/out for purposes of accountability. Although children in drop-in programs do not require care and supervision, staff is not prohibited from directing them in the proper and safe use of equipment; providing instruction, and preventing unruly conduct such as fighting.
